The Lowcountry Rapid Transit project is moving full speed ahead in 2021 starting off with public outreach to stakeholders along the corridor. Municipal coordination is ongoing as we prepare for more neighborhood meetings and continued outreach with organizations throughout the region.

Outreach in 2021 will include public meetings, sitdowns with businesses and neighborhoods along the corridor, pop-up events and more.

This work will include a mixture of in-person (as appropriate) and virtual engagement.

And it means existing relationships will be deepened and new connections will be established.

Here's a few examples:

- A virtual public meeting launch in Q1 2021. LCRT station designs will be unveiled and you can explore how the project operates along the recommended route.
- Get "Onboard with LCRT" as we travel to different locations along the corridor and engage with business owners and neighborhood leaders in a unique pop-up setting.
- Weekly Virtual Rush Hours will set time for people to have conversations with members of our project team.

These plans align with our coordination with partner organizations and municipalities to increase project awareness in our community.
