National Environment Policy Act (NEPA) documentation has been completed and "approved" by FTA



30% design plans are complete -- This includes the system's start and end points, station locations, and station architecture.



Initial readiness documents have been submitted to FTA. The team is actively coordinating on submitting an application for approval to move into the next place.


