The Lowcountry Rapid Transit project is proud to report that we have progressed through 2020, keeping the project on schedule while incorporating a mix of safe and efficient virtual and inperson engagements and coordination. We look forward to thoughtful engagement next year.

Even in the face of challenges this year, our team has continued work on Lowcountry Rapid Transit, setting the foundation that will serve as the base for future transit in our region. The recommended route delivers the right mix of cost and ridership needed to gain support from the Federal Transit Authority's Capital Investments Grants program.

This year's decisions allow LCRT to proceed as a World Class BRT and the first mass transit system in the state.

Looking forward to 2021, the project team will start off with a focus on engagement through public meetings for businesses and neighborhoods along the corridor. This work will start with a mixture of in-person and virtual events as allowed where public comment will be solicited and received. From there, work will be focused on completing NEPA documentation, finishing up 30% design and preparing all documentation to request funding in the summer of 2021.

- Completion of Final Traffic Report and Station Area Plans.

The Transit Oriented Development (TOD) Study is moving forward thanks to coordination with municipal staff and stakeholders in Summerville. North Charleston and Charleston. Additional contact with policy makers focused on affordable housing, business development, multi-modal integration and regional growth took place throughout the year. Moving into next year further community outreach will shape the policy recommendations for the station areas identified leading towards a regional approach for success.

## Scope & Schedule

**LCRT** is competitive for federal funding. Funding is a critical piece of the puzzle in identifying a successful system for implementation. The keys to success in qualifying for federal funding in the CIG program are the project's overall cost and ridership.

The team's number one goal today is to deliver a competitive project and secure federal funding, which is needed to ensure LCRT becomes a reality.
